The designs and bidding documents should allow a contractor to prepare a realistic bid for the rehabilitation of the roads with good quality of works using reasonable quality control and provide the RRB with a tool for quality assurance and contract management; and (ii) Supervision of civil works implementation.

The minimum technical score required to pass is 70 points

If none of the scores awarded by the TEP reach or exceed the minimum technical score (St), the RRB reserves the right to invite the Consultant receiving the highest technical score (St) to negotiate both its Technical and Financial Proposals. If the negotiations fail to result in an acceptable contract within a reasonable time, the RRB reserves the right to terminate the negotiations, at its sole discretion, and to invite—again, at its sole discretion—the Consultant receiving the next highest technical score (St) to negotiate both its Technical and Financial Proposals.

The formula for determining the financial scores is the following:

$S_f = 100 \times F_m / F$, in which S_f is the financial score, F_m is the lowest price and F the price of the Proposal under consideration.

The weights given to the Technical and Financial Proposals are:
