The Bidder shall include in its bid documentary evidence of contract performance in form of:
    - a. Copies of signed contracts/purchase orders,
    - b. Copies of signed delivery Notes / Goods received Notes
    - c. Copies of certificates of acceptance of the goods
  - (iii) Availability in Belize of adequate spare parts and after sales services for the vehicles offered in the bid. and the Bidder shall demonstrate that it has successfully completed at least two (2) contracts of similar goods in the past six (6) years.
